Conditions of Use

1. We will not include any details or full names (which means first name and surname) of any child or adult in an image, video or on our website, or in printed publications, without good reason. For example, we may include the full name of a competition prize winner if we have their consent. However, we will not include the full name of a model used in promotional literature.
2. We will not include personal email or postal addresses, or telephone or fax numbers on our video or on our website or in printed publications.
3. If we use images of individual pupils, we will not use the name of that child in the accompanying text or photo captions without good reason. If a pupil is named in the text, we will not use a photograph of that child to accompany the article without good reason. For example, we may include a picture and full name of a competition prize winner if we have their consent. However, we will not include a picture and full name of a model used in promotional literature.
4. We may use group or class images with very general labels, such as “a science lesson” or “making Christmas decorations”.
5. We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.
